 - 1. Meeting was declared open at 20:09hrs. Peter Bullen was elected as Chairman for the meeting; proposed by V.Freeley, seconded by S.Neatham.
 - 2. Calling Notice for the meeting as circulated to the membership on 26th December 2018 was accepted as correctly issued. Proposed by C.Lodge, seconded by B.Edrupt.
 - 3. Minutes of the 2017 AGM, held 5th February 2018 were included with the agenda and accepted, with no matters arising, on a proposition by B.Edrupt, seconded by C.Lodge.
 - (A). Annual reports from Officers were presented. Chairman, Secretary, Capt, Membership, Time Trialling, Track Racing, and CycloX reports were adopted on a proposition by C.Lodge, seconded by J.Verby.
 - (B). Treasurers Report and balance sheet were presented and open for any questions. Mrs.P.Lovatt asked why there is no provision for insurance of club trophies. Secretary advised that enquiries have been made and costs are very substantial due to insured items being scattered around multiple addresses. Standard householder's insurances do not normally cover items not owned by the householder. Trophies are sometimes held by members in rented and/or temporary accommodation adding to complexity. It is accepted that our older trophies are 'irreplaceable' and any insurance claim could cover only nominal metal value.

Treasurers Report and Balance sheet then adopted on a proposition by S.Neatham, seconded by J.Edrupt.

- 5. The treasurer reported no subscriptions outstanding for 2018.
- No nomination for Club President had been received.

10. Amendments to Club Rules

None received.

Road Racing and Time Trial Regulations

The membership advised of following changes to racing regulations as adopted by the committee.

Track Championship (by Chris Lodge), to simplify existing regulation.

- 1. Any track competition to count.
- Points awarded down to 10th place as follows: 10 for 1st, 9 for 2nd, 8 for 3rd etc. 2.
- 3. Any Track League points scored transfer point for point over to Club track points.
 - o For Sprint or Omnium Competitions club track points are awarded on a rider's final overall position as per 2 above.

New 'Audax' championship (by Joff Verby), to acknowledge increased participation in Audax UK. Proposed that Finsbury Park Cycling Club present a new award to the club member who gains the most Audax Points in an Audax Season. The regulation is:-

1. An Audax season / year runs from the 1st October to the 30th of September

- One point is awarded per 100KM on any ride over 200km. I.e. 2 points for a 200, 3 for a 300, 4 for a 400 etc.
- The rider must be a registered Audax UK member and has Finsbury Park Cycling Club listed as their club in their membership.

Amend Regulation 4. (by Brian Edrupt), to delete reference to N&WHC RRA and confirm that RRA is still operational, as follows:-

The Club will present to any member breaking an RRA record a special plaque or award to the value not less than £10. There will be no limit to the number of awards during any one season.

11. Any Other Business.

Pat Lovatt commented on the absence of a trophy for Womens Road Racing Champion and said that Sid is prepared to offer one of his many trophies for that purpose. Secretary responded with thanks and said the committee will discuss the possibility.

Brian Edrupt asked what progress has been made with regard to obtaining medals as there in now a three years backlog.

Secretary apologised for the very regrettable lack of progress and promised to have the situation resolved by end of 2019 season. A new supplier is needed due to unacceptable price increases by our current supplier.
